THROUGHOUT THE YEAR, WE SUCCESSFULLY COLLECTED AND RECEIVED GENEROUS DONATIONS OF GENTLY USED BIKES FROM COMMUNITY MEMBERS, LOCAL BIKE SHOPS AND PARTNER ORGANIZATIONS. EACH BIKE WENT THROUGH REPAIR AND REHABILITATION PROCESS. ALSO, THESE BICYCLES WERE EQUIPPED WITH SECURE LOCKS AND RECHARGABLE FRONT AND BACK LIGHTS, ENSURING THE SAFETY AND SECURITY OF OUR BENEFICIARIES DURING THEIR COMMUTES.
